From the **Court Schedule**, you can view all cases scheduled for judges, attorneys, and cases, search by date and/or time, or by case number or name.

Step-by-Step

You may get there by:

- 1. Entering the search criteria
- 2. Highlight the case or the associated name
- 3. Select the Court Schedule tab from the Index View screen as shown below



You can view the schedule either for the current day, days, months, or a year.

You can do so by entering the desired information in the date, time, who, and for fields.
